THE TRUSTEES OF THE ANNUAL CONFERENCE

The Board of Trustees ("Board") continues to pursue the proper disposition of properties of discontinued and abandoned churches. A legacy of dozens of properties, the locations of some of which were unknown at the outset, has now been substantially addressed. In a number of instances, the Board has been able to act on properties through sale or other disposition.

The Board conveyed the property of the discontinued Center Methodist Episcopal Church, South (Oconee County, Anderson District) to the Oconee Heritage Center. This historic property is destined to become the centerpiece of the Oakway community for ecumenical and community activities. This good news story illustrates the variety of ways in which the Board has approached finding caretakers for the properties of long abandoned or discontinued properties.

A letter was sent to all the churches in the Anderson District inviting them to become caretakers of the Asbury-Clark property. A caretaker has been identified and will be announced early in 2011. The caretaker will receive each year a portion of the annual net income from the Asbury Clark Cemetery Endowment Fund to care for the cemetery. The creation of the endowment was authorized by the 2009 Annual Conference. The endowment is maintained by The South Carolina United Methodist Foundation, Inc. The Rev. Dr. Roger M. Gramling, President of the Foundation was of invaluable assistance to the Board on this project.

An agreement was reached with a realtor to market the property of the discontinued Woodside UMC in Greenville County.

Discussions were undertaken with the Cemetery Association of Pisgah United Methodist Church in the Columbia District to perpetuate the care of the cemetery and the church building of the discontinued church. These discussions have been extended to include Fair Lawn UMC as a potential caretaker for that cemetery.

Pursuant to the direction the 2007 Annual Conference, the Board is sponsoring a resolution to this annual conference that recommends the use of the funds from the sale of the property of the discontinued Spring Branch UMC in Marion County. The Board seeks to use the funds for its work in dealing with discontinued and abandoned properties.

The Board conveyed the property of the discontinued Wesley UMC (Williamsburg County, Florence District) to Mt. Zion UMC which has cared for the cemetery property for many years.

Attached to this report and incorporated by reference herein is an accounting of the funds of the Board of Trustees for this past year, along with a listing of all real property being overseen by the Board, as required by paragraph 2512.6 of the 2008 *Book of Discipline*.

Much work remains to be done. The Board - looks forward to its continued service on behalf of the Conference.
